Background

Since 2009, the Embassy of Ireland has provided high quality advance education opportunities to talented Vietnamese citizens.

Scholarships are generally awarded for full-time study in the Higher Education Institutions in Ireland at Masters Level. On completion, scholarship students resume work in Vietnam and put their newly acquired skills to use for the benefit of their home country. To date 236 scholarships have been awarded to Vietnamese candidates under the Irish Development Experience Sharing (IDEAS) programme.

IDEAS Scholarship Scheme

The programme provides 30 scholarships per year.

Scholarships are provided to pursue studies in the following disciplines:

- Agriculture and Food Science
- Economics and Finance
- ICT
- Politics, Law, Human Rights
- Management and Business
- Medicine, Pharmacy and Biotechnology
- Social Policy and Development Studies
- Tourism and Hospitality
- As well as other subjects such as Data Analytics, Al, New Media.

Scholarship awards cover: return airfare, course fees, public health insurance, a stipend to cover accommodation and subsistence costs and a settling-in allowance while studying in Ireland.

The eligibility criteria are as below:

Academic qualification	Academic qualifications required by your chosen course
Language proficiency	English : IELTS: 6.5 overall (Academic), no band under 6.0

Additional requirements	Be able to demonstrate a strong commitment to the development of their home country and return to home country at the end of course. Be able to take up the fellowship in the academic year for which it is offered.

The timeframe of the selection process is as follows:

- > Stage 1: Scholarship applications, shortlisting by the Embassy
 - Step 1: Interested candidates submit applications to the Embassy —August to November
 - Step 2: Short listing and interview by the Embassy/consultant February
- > Stage 2: College applications, scholarship award
 - Successful shortlisted candidates submit college applications April
 - Scholarship award July
